I write to provide my strongest recommendation and support for the nomination of **Ms. Lisa Peterson, MS**, Nutrition & Wellness Extension Educator for Christian, Jersey, Macoupin, and Montgomery counties within University of Illinois Extension. I provide my unconditional recommendation and highest level of enthusiasm as Associate Dean and Director of University of Illinois Extension.

Ms. Peterson has been a Nutrition & Wellness Educator with Illinois Extension since June 2014. She holds BS and MS degrees in Nutrition, Exercise, and Food Science, with an emphasis in food safety, from South Dakota State University (SDSU). She served as a Graduate Research Assistant for two years with SDSU Extension before joining Illinois Extension. Lisa has assumed increasingly more complex responsibilities with Illinois Extension due to her strong content, technical, and interpersonal knowledge and skills. She is an invaluable member of our Family and Consumer Sciences (FCS) team and works to integrate nutrition and wellness programs with our Illinois Nutrition Education Programs, agriculture and agribusiness, 4-H Youth Development, and community and economic development programs.

Of note is Ms. Peterson's service as the Nutrition & Wellness state team leader in 2020. She worked to find solutions for the team to work more closely together and to address challenges of the COVID-19 pandemic. She served on the statewide diversity, equity, and inclusion committee, along with numerous team committees dedicated to developing chronic disease prevention, food preservation, nutrition, and food safety programs for a wide variety of audiences. She has been a member of several working groups within the multi-county unit that she serves, including the Illinois Project for Local Assessment of Needs for the four respective health departments. She was asked to serve as the Acting County Director for her unit from 2021-2022, due to her strong leadership skills and understanding of issues and needs in west central Illinois. She provided exceptional leadership in this temporary position.

Ms. Peterson uses her knowledge to serve as a National Fight Bac Ambassador for the National Partnership of Food Safety Education and is one of the Illinois representatives for the North Central Food Safety Extension Network. She is also an active member of the Society for Nutrition Education and Behavior.

Specific to national leadership, Ms. Peterson is currently completing a very successful term as National Secretary (2022-2024). She served on NEAFCS' Mentoring and Leadership Committee for three years (2021, 2022, 2024) and contributed to the National Mentoring and Leadership pilot program. She created marketing graphics, developed profiles for all 37 national FCS Extension professionals across the country serving as mentors and mentees, and produced the 77-page curriculum book. She has critically evaluated

the marketing efforts to improve and elevate access to the program. She also served as the Chair of the Leadership Experience Marketing Sub-committee.

Ms. Peterson won the 2023 NEAFCS Marketing Award as part of the Illinois Nutrition & Wellness team. She contributed to writing regular newspaper columns and creating social media graphics regarding food preservation. She has proficiently used design platforms like Canva, PicMonkey, Mailchimp, and Microsoft Suites. She was also selected as the recipient of the University of Illinois Patricia J. Buchanan Extension Professional Development Award (2023) in recognition of her numerous unit, state, and national leadership contributions.

Within Illinois, Ms. Peterson has served as the Illinois Vice President of Member Resources (2019-2022). She effectively communicated with FCS members across the state to ensure that they has the materials and information needed to perform their jobs efficiently. She also communicated to Illinois members about the national resources available to them to enhance their NEAFCS and IEAFCS experiences. She currently serves as our Illinois President-Elect, engaging in a variety of duties to further the goals and objectives of IEAFCS.
