It is a pleasure to provide a letter of support for Keishon Thomas' nomination packet for NEAFCS Southern Region Director. Ms. Thomas is an outstanding Family and Consumer Sciences Agent and would be an excellent regional director.

Ms. Thomas can relate to NEAFCS member's program knowledge and work experiences because of her own broad family and consumer sciences programming and achievements. Ms. Thomas is an accomplished professional and has an established record of productivity and innovation in bringing together partners to develop and deliver programs and resources to impact Georgia and the Southern Region. As indicated in her candidate packet, she has educational impacts in diverse content areas, including healthy home environments, human development, nutrition education, chronic disease prevention, and financial literacy. Her program impacts have earned regional and national recognition. Just as an example, Ms. Thomas educated 140 women through the *Cooking For a LifeTime: Cancer Cooking School*. She reached women who were rarely, or never, screened for breast, cervical, and colorectal cancers. As a result, of the program, 15% of the women were eligible for resources for services they could not otherwise afford, and 91.3% reported the intent to get a mammogram. Ms. Thomas has secured \$103,165 in extramural funding to support programs. She has presented posters and presentations at international, national, and state conferences, and has authored and co-authored journal articles and Extension factsheets.

Ms. Thomas provides leadership for people and teams. Most recently, Ms. Thomas served as the chair for the NEAFCS Awards and Recognition Training Sub-committee. As part of her responsibilities, she led a collective of Extension professionals to develop articles, webinars, and videos about awards. She has also updated several publications regarding awards for NEAFCS. Ms. Thomas is a productive and committed team member. She has served effectively on numerous UGA Extension committees and served in various leadership positions with NEAFCS, GEAFCS, and Epsilon Sigma Phi.

Ms. Thomas lights up a room with energy, enthusiasm, and positivity. She is an excellent communicator and an accomplished collaborator. She is open and relates easily to others, which draws her peers to her. Her approachability, ability to build new relationships quickly, and communication needs and concerns between multiple groups make her the perfect candidate to serve as a regional director.
