- We are proud is that we have one of our own Marcia Parcell who has a National Position, the VP of Professional Development. We also have Caroline Everidge who is the Chair for the Diversity, Equity and Inclusion Committee.
- As a section we have decided to add a Diversity, Equity, Inclusion and Belonging Committee to align with the National Subcommittees.
- Our VP for Awards continues to host a virtual meeting to discuss different awards (national and state) as well as
 the application process. Of the 9 team/individual applications submitted by educators Indiana received 5 awards
 at Annual Session, 3 at the regional level and 2 at the national level. Diana Stone was recognized with the
 Distinguished Service Award.
- Over 500 programs delivered.
- We continued to raise funds to again support the Dean Don Felker Award for another year. The affiliate did discuss ways to continue to finance the award, as well as changing to a scholarship verses cash award.
- We do continue to have new educators that started this year to join NEAFCS.

What are your Affiliate's goals for the next 12 months?

- The New President has already planned an officer retreat to truly re-establish officer roles and create an action plan for moving the affiliate forward
- Revitalize Indiana NEAFCS committees as well as participation on national committees
- Encourage members to apply for awards and to present at Annual Session.
