- Kelly Knight, NM affiliate President, and Karen Plawecki, NM affiliate Vice President for Awards and Recognition served as voting delegates at the 2023 NEAFCS annual business Meeting.
- Two business meetings were held for the NM affiliate in 2023. Both were held via Zoom meeting.
- Kelly Knight, NM affiliate president, attended one NM Cooperative Extension Service Director's Advisory Board Meeting on behalf of the NM affiliate.
- NM affiliate officers for 2024 were elected electronically in December 2024. The list of NM affiliate officers and committee chairpersons has been submitted to the regional director and NEAFCS National Office.

What challenges do Cooperative Extension and/or Family & Consumer Sciences face in your state?

- Decline of memberships. The NM affiliate has seen a 29% reduction in members compared to membership in 2016.
- Retention of Extension Agents and Specialists.
- Recruitment of applicants for Extension Agent and Specialist positions.
- Operational budgets for County Extension Agents are low and have not been increased for many years.

To assist NEAFCS in future planning and communication, please list concerns your Affiliate has for the NEAFCS Board to address:

- Costs of sending affiliate officers to attend JCEP and PILD.
- Keeping dues and Annual Session costs as low as possible for members. Due to limited operational budgets, often Extension Agents are not able to join as members nor attend Annual Session due to costs.
- Continue to work toward streamlining the budget for effective and efficient use of professional dollars, as well as making it possible for members who are not able to attend the Annual Sessions due to budget restraints to glean some of the information electronically.
