There can be some confusion about awards deadlines. March 15th is the deadline for affiliate Awards and Recognition Vice Presidents to send their winning award submissions to NEAFCS for National and Regional judging. However, prior to March 15th, each affiliate has their own submission deadlines and judging process to determine which applications will move forward to NEAFCS. Many affiliate deadlines



have already passed, and many are just around the corner. Check with your affiliate Awards and Recognition Vice President about your affiliate's submission deadline.

NEAFCS will soon be making a call for judges to review the National awards submissions. I encourage you to consider serving as a judge this year. In addition to supporting NEAFCS in the awards process, it is also an opportunity to learn more about the amazing work your peers are doing and to experience being a part of the judging process.

Even if you haven't completed an award application before, going through the process of reviewing applications and completing judging sheets will help you think more like a judge. This will help you write a stronger application when you decide to submit for an award.

When you see the call for judges, consider taking the time this spring to recognize the work of your peers while also strengthening your future award applications at the same time.

Living Well

Café Latino Working With Diverse Spanish Population Nelly Nelson (FL), Diversity Committee

There are five million Spanish speakers in Florida (out of 21 million residents and growing). This large portion of our population can be better served if we are able to provide more materials and support in Spanish. The Coalition of Florida Extension for Latino Communities (CAFE Latino) is assisting in this effort. In addition, CAFE Latino is gaining visibility in Extension across the country (as well as international inquiries), and as such requires a robust presence.

As part of the University of Florida's Diversity Initiatives, CAFE Latino (created in the spring of 2018) was built and designed by UF/IFAS Extension faculty to help increase the capacity and competency for Extension to serve the needs of Florida's growing Latinx population. It is recognized by the university's inclusivity initiatives led by the office of Diversity.

CAFE Latino represents a grassroots service organization that is focused on enhancing the access and efficacy of Extension programs. Comprised of Extension faculty and staff across the state (with expertise in all program areas), the 50 members of CAFE Latino are not solely Latinx faculty and staff. Instead, the group includes representation from various racial/ethnic groups. We invite all who are interested in advancing culturally responsive programs for multicultural audiences.

Eastern Region Affiliate Updates: DASH Plus for Older Adults in Maryland

The University of Maryland Extension (UME) received an USDA.AFRI grant in 2021 to implement a new healthy living program targeting older adults with hypertension. The DASH Plus program is an integrated project that aims to build a sustainable, community-based hypertension management program within senior centers. The intervention includes 8 nutrition education modules highlighting important components of the Dietary Approaches to Stop Hypertension (DASH) eating plan with the addition of a physical activity component in each module and other hypertension self-care skills.



A virtual pilot of these modules was taught by selected UME-FCS educators in 2021. In the summer of 2022, the complete DASH Plus program will be implemented by these educators in senior living communities across the state. In addition to the education component, participants will receive blood pressure education and supplies to measure their blood pressure at home. The final component is a weekly delivery of fresh produce to increase their access to fresh fruits and vegetables, an important component of the DASH eating plan. A culture of heath will be promoted through a peer support model. This research study aims to identify components that can improve older adults' blood pressure management.
