## **Bylaws Proposed Changes**

Bylaws are the operating rules that guide the internal affairs of an organization. Each year the bylaws committee gives careful and cautious attention to consideration of changes. The general content in bylaws is standard for organizations and revisions are made only when necessary to reflect new goals, changing environment, or new operational needs. Information that changes frequently are included in standing rules or procedures manual.



Proposed bylaws changes are to address membership classifications. The bylaws committee researched membership categories/classifications (requirements as well as rights and privileges) in other Extension national organizations as well as Family and Consumer Sciences organizations. Simplicity and inclusion were recurring themes. With the intent of being a welcoming and inclusive organization, the proposal is to have five membership classifications:

- 1. Active Member part A stays the same and part B includes what was previously called associate member (for employees located where there is no state/territory affiliate).
- Associate Member new category for Extension employees with less than a bachelor's degree. Membership in a national organization is a step towards encouraging Extension employees to further their education and see Family and Consumer Sciences as a viable career path.
- 3. Life Member stays the same.
- 4. Partner Member stays the same.
- 5. Student Member stays the same.
- \*Note: Member-In-Transition removed, being used infrequently.
- \*Note: There are some differences in rights and privileges as well as dues for the five membership classifications.

The other changes throughout the bylaws are related to the membership categories. The only exception is Article III – Dues and Fees, new section 3. This clarifies when an increase in dues becomes effective after a vote at an Annual Session.

The OSU Extension Community Nutrition Education Program (CNEP) in Oklahoma has been involved this summer with a program called Harvest Highlights who partners with the Oklahoma Nutrition Information and Education (ONIE). CNEP's Nutrition Education Assistants travels to their local Farmer's Markets and record videos of the vendors and their produce/goods to post on the OSU Extension County websites and Facebook pages. ONIE has supplied tokens for purchasing, canvas bags and recipe cards for patrons. Also, the



Nutrition Assistants conducts a food demo with the highlighted food items and posted it as well. This is being done once per month in the 3 summer months across Oklahoma.

In November 2021, working in collaboration with 7 other Extension offices across the country, Brad Averill, a UGA Extension Family and Consumer Sciences Agent started a "30 for 30 Walk-a-Weigh" Facebook Group. The idea of this project was simple. Walk for 30 minutes per day for 30 straight days. Members were asked to post pictures of their daily walks. At the conclusion of the "30 for 30 Walk-a-Weigh" on May 31st, 2022, the group had 1,353 members who have submitted 3,476 posts, 3,883 comments, and 49,106 reactions.

# Ohio Update: Healthy for Life Community Nutrition Program *Tammy Jones (OH), Ohio Affiliate President*

Jenny Lobb, MPH, RDN, Family and Consumer Sciences Educator for OSU Extension, was recently awarded \$2500 to implement the Healthy for Life Community Nutrition program at the Mount Carmel Healthy Living Center (MCHLC) in Columbus, OH. Founded in 2015, the MCLHC is a community health and wellness center that provides free health and wellness education to community members. The MCHLC serves individuals who live in and around zip code 43222 where it is located. This community, known as Franklinton, currently has the lowest life expectancy in the state of Ohio (https://www.healthpolicyohio.org/2021-health-value-dashboard/).



In July-August 2022, Jenny will deliver four educational experiences from the Globally Inspired Home Cooking module of the Healthy for Life curriculum to approximately 25 people served by the center. Each experience will include a food demonstration and tasting, and participants will take home a meal kit after each experience so they can prepare recipes from the curriculum on their own. In addition, participants who attend all four classes and complete a post-program evaluation will be entered into a raffle to receive an appliance such as an air fryer or electric pressure cooker.

# Future Retirees Needed – Become a Life Member!! Michelle Wright (TX), Vice President for Member Resources

Has retirement crossed your mind lately? NEAFCS Life Members have sounded the alarm for all future retirees to join the ranks after retirement by becoming a Life Member! If you can answer yes to the following after retirement, you can be a Life Member! Have you served as an active or affiliate member of NEAFCS for at least five (5) years and have retired, resigned, or otherwise become ineligible for active or affiliate membership, join this select group of retired Extension professionals!! The final step is making a one-time payment of \$300.00 to NEAFCS. If for some reason you ever want to re-enter the Extension



service, you will be required to resume active membership status and pay annual dues. Download the Life Member application today!

Life Members have the following rights and privileges:

- a. They may receive awards, fellowships, and grants.
- b. They may serve on committees, serve as committee chairs or hold elected office.
- c. They may serve as voting delegates when a state/territory affiliate lacks sufficient delegates to the Annual Business Meeting.
- d. They shall receive the NEAFCS Annual Session registration information. They shall pay registration fees at the same rate as Active Members unless a special rate for Life Members is established.
- e. They shall be granted access to NEAFCS.org, which includes publications and other resources, upon payment of dues.
- f. They may submit proposals to present at NEAFCS Annual Sessions through the Program Review Process.
- g. They may submit articles for publication in the Journal of NEAFCS.
- h. They may attend and submit proposals to present NEAFCS webinars.

#### We Don't Know, But It Will Be Good

Why give to the NEAFCS Endowment? What will come from my contribution? Those are very appropriate questions. Interestingly, even though I am a contributor AND an advocate for the endowment, the only answer I can give is this: "We don't know."

What? That's not much of an answer!! Or maybe it is. . .

I see a comparison to the story told in "The Secret History of Home Economics" (2021) by Danielle Dreilinger. The Iowa NEAFCS affiliate is exploring this book this summer, and one of the things that struck me was the important role that money and other resources played in our history. The Lake Placid Conferences (1899-1909) played a major formative role in our

profession by gathering people together to share ideas and define our vision. There were FUNDERS that helped make those conferences possible.

Of course, it wasn't *only* money that mattered. There were already visionary leaders who had started to look at household challenges in new, scientific ways. But had there not been a focused gathering of those visionaries – a gathering made possible by FUNDS – the new profession might not have been formed... or at best it would have been formed more slowly and less cohesively.

But when the funders and participants committed to the first Lake Placid Conference, did they know what would come from their contributions? No. They didn't know. They just knew they were putting a process in place. And they made progress. It was good.

That's how it is when we contribute to our NEAFCS Endowment Fund – we're investing in an unknown future for our profession. We don't know more than a year ahead *exactly* what the money will be used for, but we know that NEAFCS has a project funding process in place that's guided by experienced and committed people. WE (all of us as NEAFCS members) have the opportunity to use that money to try something new and different – something that will bring progress to our Extension Family and Consumer Sciences profession.
