


### Celebrating Black History Month by Advancing Nutrition Security and Health Equity

mansion. Every school day, I got on the bus in my modest Adamsville neighborhood where there weren't many restaurants serving healthy meals, destined for a picturesque neighborhood featuring abundant food options. Though Adamsville didn't have posh restaurants, we had each other. My mother ensured our meals were rich with vegetables from our garden, the nearby supermarket, or Mr. Bell's neighborhood produce truck. I was so lucky to grow up in a neighborhood where neighbors and friends looked out for and cared for one another. As I explained in this video, at the time I didn't truly understand how differences in

access to healthy retail food outlets affected our quality of health – really, our quality of life.

Now, with nutrition security as my focus, I am honored to continue my parents and neighbors' legacy by working to ensure everyone in this country has consistent and equitable access to healthy, safe, and affordable foods. In my role at USDA, it's such a pleasure to remember my roots and blossom in my ability to engage people from all demographics and life stages. So please join me in partnership to advance food and nutrition security. Everyone can put on their imaginary backpacks and "get on the bus" so we can collectively ensure that no child ever wonders why their neighborhood lacks healthy food choices. USDA's suite of 16 federal nutrition assistance programs already reaches 1 in 4 Americans. And with your help, we can reach even more and prevent ZIP codes from defining life expectancy. We have the collective power to ensure everyone in this country is set up to thrive.

Should NEAFCS stay with the regional model or hold the Annual Sessions in locations with lower overall costs?

**Awards and Recognition.** Family and Consumer Sciences is ever evolving, and more of the focus in recent years has moved to personal wellness and mental health. Can the current awards be reviewed and perhaps updated to reflect these new areas of focus? For example, in addition to the Family Health and Wellness award, could there be one more focused on individual wellness? Chronic disease prevention and management? Mental health and wellness?

**Member Resources.** More FCS agents are being hired who do not have Family and Consumer Sciences degrees. Are there ways to have seasoned Life Members serve as Content Resources for newer agents needing content and experience information and guidance?

Can NEAFCS have a stronger marketing program to non-traditional FCS colleagues? For example, how could we encourage 4-H staff without an FCS appointment to feel like they "fit" at NEAFCS because they're still working with families? Or human development colleagues?

**Professional Development.** Are there ways members who cannot attend Annual Session can have access to the professional development after the conference?

**Public Affairs.** For many members, the cost of attending JCEP and PILD is prohibitive. Could funding be considered to assist more members in attending? Both conferences offer excellent professional development and opportunities to present workshops and posters.

# **Editing and Proofreading Awards Applications**

process that are often rushed or overlooked. We have all done it; we worked so hard putting a presentation/packet/report together and then hit submit only to realize a typo after our finger left the button. We focus so much on getting the content together, that we neglect to devote the time necessary for proper editing and proofreading. When you are working on a report and spending hours mulling over the words and information, your brain starts to fill in the gaps between what you meant to say versus what you typed. This is why it is so important to have a second and even third set of eyes proofreading your award application.



The University of Arkansas Little Rock Writing Center offers the following tips for effective proofreading:

**Proofread backwards.** Begin at the end and work back through the paper paragraph by paragraph or even line by line. This will force you to look at the surface elements rather than the meaning of the paper.

Try to take a break between writing and proofreading. Set the paper aside for the night — or even for twenty minutes.

**Proofread once aloud.** This will slow you down and you will hear the difference between what you meant to write and what you actually wrote.

**Ask someone else to read over your paper** and help you find sentences that aren't clear, places where you're being wordy, and any errors.

**Read through your paper several times**, once looking just at spelling, another time looking just at punctuation, and so on. Again, this can help you focus so you'll do a better job.

Use the spell-checker on your computer but use it carefully and do your own spell-checking. Computer spell-checkers often make errors – they might suggest a word that isn't what you want at all, and they don't know the difference between there, their, and they're, for example.

#### What is the Deal with Pronouns?


You may have been in a meeting or introduced to someone and they have shared the pronouns they identify with. If you have ever wondered what this is all about, let me share an overview.

Pronouns are used as a substitute for someone's name, and they are often based on assumptions about the person's gender, appearance, or name. When we use the pronouns a person identifies with, it shows respect and gives

on your e-mail signature line, nametags, and business cards.

them dignity. When we make pronoun or gender assumptions, it can feel disrespectful and alienating, especially when we don't get it

right. Most importantly, using correct pronouns is about suicide prevention. According to the Trevor project (<a href="https://www.thetrevorproject.org/">https://www.thetrevorproject.org/</a>), the attempted suicide rate is cut in half for transgender and non-binary youth who have their pronouns respected.



Why do some people refer to themselves as "they"? They/them pronouns can be used by a singular person who does not identify as a man or a woman (we can call this non-binary). If the use of they/them to refer to one person seems foreign to you, it can be helpful to remember that how we use language evolves over time. It may just take some practice to get used to it!

Finally, if you use the wrong pronouns for someone, just apologize, correct yourself, and move on!

# "if we organized in 1933, isn't celebrating our 90<sup>th</sup> Anniversary in 2024 a year late"?

We are celebrating our 90<sup>th</sup> this year because just like our own birthdays and anniversaries, at Annual Session 2024 we will be completing our 90<sup>th</sup> year.

Annual Session 2024 will include the culminating celebration of our organization's longevity and history. Because it is such a significant milestone, we decided to celebrate it all year long, with on-going activities for affiliates, a special NEAFCS Creed competition, and many 90<sup>th</sup> Anniversary touch points at Annual Session 2024.

With that question aside, I continue to read and re-read our organization's history this year and every time "new" things pop up, reminding me how our organization has changed over the years. For example, in addition to style shows by McCall's Pattern Company and equipment demonstrations by Presto Products and the Hoover Corporation, for many years businesses would sponsor meals, breaks, and events at Annual Session. Food companies would feature new product lines, such as in 1955 General Foods Corporation sponsored a luncheon and demonstration of one of their new products – instant pudding. A couple of years later, 1959, The Campbell Soup Company hosted a luncheon at which the new Pumpkin and Mincemeat pies by Swanson and a new combination of Turkey and Vegetables soups were introduced. At that same meeting General Foods Kitchen hosted a luncheon and had as a part of the meal the new Jello glazed Danish sandwiches. I know we can still purchase instant pudding, pies, and soups. I wonder what happened to those Jello glazed sandwiches!
