## Use Ala carte prices to cut your expenses for attending 2024 NEAFCS Conference

Celebrating NEAFCS' 90<sup>th</sup> Anniversary should make travel to our Conference a must on your travel list. However, it can get expensive. As Life Members we now have the option of choosing ala carte for conference offerings. This can cut down your costs and allow you to choose what you want to attend or can attend for the days you are at the conference. Remember ala carte pricing is based on costs to the Association (*They are not making money on this.*).

Ala carte pricings for this year are:

- Monday, Opening General Session and Welcome Event -\$125
- Tuesday, Life Member Meeting \$25
- Tuesday, Regional Business Meeting & Awards Luncheon \$70
- Wednesday, Exhibit Lunch, Exhibit Hall, Silent Auction and Annual Business Meeting - \$75
- Thursday, Exhibit Hall \$15
- Thursday, Reception and Awards Banquet \$125

If you attended all the events listed above the total price would be \$435. This can save you \$90 over the conference member rate of \$525 and still allow you to enjoy most of the conference activities we all love, including our 90<sup>th</sup> celebration on Thursday evening at the banquet. This ala carte does not include concurrent sessions or other educational offerings or sessions. If you want to attend concurrent sessions or other educational offerings you will need to pay the full conference fee of \$525, if paid before August 1<sup>st</sup>

**Don't forget to sign up for our Life member in-depth session on Tuesday morning, when the other in-depth sessions are. This is a Life Member-only tour** of a 98-acre Desert Museum, a fusion of zoo, botanical garden, art gallery, natural history museum, and aquarium. You will need to register separately, and the cost is \$90, which includes bus transportation and the tour. All in-depth sessions cost extra.

Notice our Life Member meeting will be Tuesday afternoon. You will need to sign up for it with the cost of \$25. We will have coffee, tea and water available at the meeting. This meeting follows the Regional Lunch meetings.

## What's a webinar got to do, got to do with promotion?

You may be wondering why the Webinar Committee is providing an article

**about promotion**. Hopefully, this message will inspire you to submit a webinar proposal! Earlier this year in his president's message, Rick Griffiths encouraged members to submit a webinar proposal and to register for upcoming webinars or to watch recorded webinars on the website. NEAFCS webinars can increase your professional development AND YOU can help increase other members professional development by providing one.

Whether you are a seasoned Extension professional or are brand new, promotion is something you likely want to consider sooner rather than later. Each university and Extension system has its own requirements.

While some promotion pathways are similar, it is important for you to know your organization's promotion and tenure process and the requirements you must meet to achieve promotion.

Typically, you must have been in your 'rank' for a minimum of 3-6 years before you can apply for a promotion. Expectations increase as you move up the levels, and you must demonstrate that you can meet them BEFORE being considered for **promotion**. Some areas considered when applying for promotion include presentations, service, creative works, scholarly contributions, conference proceedings, funding, and awards. NEAFCS can help you meet the requirements in most of these categories.

NEAFCS Webinars are peer-reviewed national presentations. Some of you may not have the budget to travel to a national conference or you may not have a submission accepted each year. NEAFCS Webinars offer a great opportunity to help you meet your universities promotion expectations without leaving your office! You can partner with a colleague from anywhere in the country. All the behind-the-scenes logistics and promotion are handled by the national office. You develop your presentation then show up to teach! It doesn't get much easier than that! So, what's keeping you from sharing the great work you are doing with your fellow NEAFCS members?

# Diversity is Moving: From 1906 to 2024 and Beyond

Tuskegee Institute's George Washington Carver first used the Jesup wagon in 1906. It was a mobile classroom that allowed Carver to teach farmers and



sharecroppers how to grow crops like sweet potatoes, peanuts, soybeans, and pecans. This was one of the greatest contributions to Cooperative



Extension, and variations of this vehicle are still used today to reach underserved audiences.

For example, in 2011, Alabama passed a state immigration law called House Bill 56. At the beginning, Alabama Extension's health and nutrition team at Alabama A&M had slow turnouts for Hispanic health and nutrition programs due to House Bill 56. Therefore, they devised a new marketing strategy to take nutrition education to them through the Nutrition Education Lab. The Nutrition Education Lab was equipped with a small kitchen that allowed the team to do on-site nutrition education and food demonstrations.

Today, Alabama Extension still uses modern Jesup wagons to reach diverse audiences through the new and improved Mobile Nutrition Lab, the Mobile STEM Lab, and a water conservation lab called Water Wheels.

## Voices from the Past – Present – Future

On June 29<sup>th</sup>, 1933, in Milwaukee, WI, during the annual meeting of the American Home Economics Association, The National Home Demonstration Agents' Association became a

**reality.** Present were twenty-one home demonstration agents from 13 states: Alabama, Illinois, Michigan, Minnesota, Missouri, New Hampshire, New Jersey, New York, North Dakota, Ohio, Vermont, Virginia and Wyoming.

The 90<sup>th</sup> Anniversary Committee has asked each of these 13 states to collect stories of their work and membership in NEAFCS from a retired or life member, the affiliate president, and a "new" member – the start of an ongoing narrative history of NEAFCS. Between now and our 100<sup>th</sup> Anniversary, stories will be collected from all of the affiliates. These stories will be included in our newsletter, on our website, and in our historical records.

It is with great pleasure that I share the next set of stories from the Ohio Affiliate, featuring:

- \* Past-Marilyn Sach-Life Member, Retired
- \* Present-Misty Harmon-OEAFCS President 2024
- \* Future-Emma Horstman



Marilyn Sachs was Home Economics Agent in Williams County, Ohio and a member of NEAFCS from 1991 until she retired in 2009. Marilyn's mother, Bernice Smith, was a Home Demonstration Agent in Illinois, Hawaii, and Ohio from 1935-1951. Marilyn's daughter, Shannon Carter, has served as Family and Consumer Sciences Educator in Fairfield County, Ohio from 1998-2005, and again 2012 through the present.

A favorite memory of NEAFCS for Marilyn was presenting at Annual Meeting with her daughter. Marilyn and Shannon shared their unique story of 85 years of FCS Extension through three generations of educators in their family, from 1935-2020. They explored generational norms that influenced their decisions in balancing work and family and ways Extension helped audiences become resilient in the face of change.
