On June 29th, 1933, in Milwaukee, WI, during the annual meeting of the American Home Economics Association, The National Home Demonstration Agents' Association became a reality. Present were twenty-one home demonstration agents from 13 states: Alabama, Illinois, Michigan, Minnesota, Missouri, New Hampshire, New Jersey, New York, North Dakota, Ohio, Vermont, Virginia and Wyoming.

The 90th Anniversary Committee has asked each of these 13 states to collect stories of their work and membership in NEAFCS from a retired or life member, the affiliate president and a "new" member – the start of an on-going narrative history of NEAFCS. My name is Synithia Flowers and I currently serve as the NEAFCS affiliate president in Alabama. I became an NEAFCS member in 2007 and have been employed with Extension for over 22 years. In my position as a Human Sciences Extension (HSE) regional agent, I cover counties that span the central and largest region of the state. A priority program that I conduct is Escape Vapes which addresses the critical needs surrounding the youth vaping epidemic. Realizing the complexities and dynamics of this issue, I helped

I have been with Extension for 7 years and have been a NEAFCS member for 3 years. I currently serve as Parliamentarian for the Alabama affiliate of NEAFCS.

As EFNEP Coordinator, I provide statewide leadership to a \$2.1 million federally funded nutrition education program that focuses on adults and youth with limited resources. NEAFCS membership has been rewarding to me for forty years. I joined because a colleague invited me and because I saw it as a professional development resource. While actively employed it kept me current in terms of Family and Consumer Science knowledge and practice as an Extension Agent. It also helped me grow as a leader. One special project I helped fashion in my last year or two as an active member was the NEAFCS Leadership Experience.
